






- Do not provide personal information in response to an incoming call. Identity thieves are clever. They often pose as representatives of banks, credit card companies, creditors, or government agencies to get people to reveal their account numbers, Social Security numbers, mother's maiden names, passwords, and other identify ing information.
- If you get an inquiry from a company or government agency seeking personal information, don't provide it. Instead, hang up and call the phone number on your account statement, in the phone book, or on the company's or government agency's website to find out if the entity needs the requested information.

Statement of Non-Discrimination

Lifeline...Making Telephone Service Affordable

What is Lifeline? Lifeline is a federal program that helps eligible individuals pay for wireless or home telephone service. The program provides discounts on one basic monthly phone service (wireline or wireless) for qualified subscribers. Federal rules prohibit qualifying low-income consumers from receiving more than ONE Lifeline service at the same time. That means qualifying low-income consumers may receive a Lifeline discount on either a home phone or on wireless phone service but may not receive a Lifeline discount on both services at the same time. You may qualify for LITAP by providing one of the following:

- * A copy of your LIHEAP Eligibility
- * A copy of your current Medicaid documentation
 - * Letter from the Human Services Dept.
 - * Proof of Income

This discount will be applied after we receive the required documentation. Your documentation must be updated every year.
